On [REDACTED], [REDACTED] the Assistant Commonwealth's Attorney, [REDACTED] [REDACTED], the Defendant, and Manuel Leiva, Counsel for the Defendant, appeared before this Court. The Defendant is indicted for the felony of ABDUCTION (Count I), and the misdemeanors of DOMESTIC ASSAULT (Count II) and DAMAGE TELEPHONE LINE (Count III), and he appeared while on bond.

The Jury was discharged.

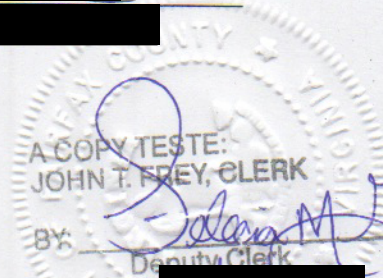
