FINAL ORDER

On 2011 the Assistant Commonwealth's Attorney, the Defendant, and Manuel Leiva, Counsel for the Defendant, appeared before this Court. The Defendant appeared while on bond.

The Court **granted**, without the objection of the Defendant or her Counsel, the Commonwealth's Attorney's motion to amend the warrant by: amending the charge from "DRIVING WHILE INTOXICATED-FIRST OFFENSE" to "RECKLESS DRIVING" and by amending the code section from "82-1-6(18.2-266)" to "46.2-852".

The Defendant was arraigned upon the amended warrant and the Defendant, in person, entered an oral plea of guilty. In consideration of the Defendant's plea of guilty, the Court found guilty of RECKLESS DRIVING, as charged in the amended warrant.

Upon the recommendation of the Commonwealth's Attorney, the Court **ORDERED** that the Defendant serve thirty (30) days in jail and pay a fine in the amount of \$500.00 and pay the costs of this case. The Court further **ORDERED** that the Defendant's license to drive be suspended for a period of six (6) months. All thirty (30) days of the jail sentence and \$250.00 of the fine were suspended conditioned upon the Defendant's good behavior for a period of one (1) year. The Court further **ORDERED** that the Defendant enter into and successfully complete the Alcohol Safety Action Program (ASAP). The Court further **ORDERED** that the Defendant be issued a restricted permit pursuant to § 18.2-271.1(E) of the 1950 Code of Virginia, as amended, to drive to and from the Defendant's place of employment, to drive to and from ASAP, to travel to and from

school, to travel to and from medical appointments, to travel to and from appointments with the probation officer, and to travel to and from programs required by court or as a condition of probation.

The Defendant was released upon the aforesaid conditions.
